Important Meeting Information

Luncheon Reservation/Cancellation Policy—Please Take Note!



Please be sure you make reservations for the luncheons prior to attending. We need the reservations to plan appropriately for our attendees and to eliminate confusion at the luncheons. You will receive a confirmation email after you submit your reservation.

Luncheons are \$10.00 for members who make their reservations by the reservation deadline, usually the COB one week prior to the luncheon. For members who make a reservation but do not attend or call to cancel, the cost is \$20.00. Individuals who attend without making a reservation will also be charged \$20.00.

To cancel your reservation and avoid being invoiced for the event, you must notify the reservationist, Mary Cole (mary.c.cole@cot.tn.gov), before the reservation deadline (usually one week prior to the date of the event). If you cancel after the deadline or fail to appear at the event, you will be invoiced for the full per-attendee cost, including other fees that apply as deemed ap-

propriate by the Board. Any pre-paid fees that you have will be applied to the invoiced amount.

Any invoices that are unpaid after 60 days will result in the suspension of membership in the Middle Tennessee Chapter under the current Chapter Bylaws Section 3.09, Non-payment of <u>Dues</u>*. As a result of suspension, any reservations you make for future events will not be **ACCEPTED** and you will not be allowed to attend Chapter luncheons or take advantage of member benefits until your outstanding invoices are paid.

We typically have a waiting list for our events, so if you must cancel your reservation, **PLEASE** notify the reservationist, Mary Cole (mary.c.cole@cot.tn.gov), as soon as possible, or you may have someone attend in your place to avoid being invoiced for the luncheon. If you have someone take your place, you must notify the reservationist or have the substitution notify the reception/sign-in table at the luncheon when signing-in.

Other exceptions may apply in extreme situations (i.e. death of a family member) and will be reviewed on a case by case basis at the discretion of the Chapter Board at the member's request.

Members, if you are inviting nonmembers to attend who are not first time attendees, please be sure that they are fully aware of their costs and our cancellation and invoicing policy. First-time guests eat free. After a guest's first visit, he or she will be charged \$20.00 according to the nonmember fee schedule. No Free Guests are allowed at joint luncheons, due to elevated costs, or Member Benefits Events, such as the December Luncheon or January Member Benefit Training Day.

Important New Information Regarding CPE Suspensions



According to the ACFE's website at http://www.acfe.com/myannouncements.aspx, beginning January 1, 2015, CFEs with five or more years of CPE suspensions will be placed into Associate member status. Should these individuals want to reinstate the CFE credential they will be required to take the CFE Exam. If you have any questions about this new requirement, contact the ACFE at 1-800-245-3321. If a CFE does not certify compliance on an annual basis, their credential will be placed into suspension. Suspended status prohibits individuals from representing themselves as CFEs to the general public and using the credential in any form.

Just What Are the Essential Elements of a Fraud Prevention Program?

Have you ever been at a place in your career as a fraud examiner where you've asked yourself, "Just what are the essential elements of a successful fraud prevention program?" If you were to develop your own fraud prevention program, would you try to recreate the wheel, or would you study the thousands upon thousands of companies via internet that boast they have the most up-to-date prevention measures on the planet and borrow from them? Decisions, decisions, decisions, decisions, decisions, decisions....

To be quite honest, if we utilized the almost unlimited and free internet resources we have, we could find out an answer by spending just a single day researching, analyzing, and duplicating all sorts of fraud prevention programs ranging from Google to Starbucks! And, thanks to the vast research methods afforded to us today, creating a great fraud program in any line of work doesn't really require any specialized skills, but in the interest of job security, we'll keep that to ourselves. While it's true that before attempting such a feat one should have some knowledge of what fraud is and how it can occur in a particular business setting, is it really so difficult that one would need to spend an enormous amount of time and resources researching and implementing something that has already been done a thousand times before in other businesses?

In this article, I would like to offer a few common elements of good fraud prevention programs that I've noted throughout my career as a public servant. In no way does this information represent the opinions of my former or current employers, but the information does offer insight into what I've learned about qualities and good business practices in fraud prevention programs I've observed over the course of my 17 years as a fraud investigator.

Below are five elements that I consider essential to any successful fraud prevention program. That's not to say that these are the only elements, but they are, in my opinion, essential to a great program.

- 1. Code of Conduct (code of ethics). To be successful, an entity should have a code of conduct, separately or in a written policy, that has been provided to every employee. It would be a huge surprise if larger entities did not have a code of conduct for their employees, but stranger things have happened. So, why is it important for the entity to have a written code of conduct... because an entity wants to be in a position to say, in the case of employee fraud, that every employee has been placed on notice that he/she is expected to act with honesty and integrity.
- 2. Fraud Reporting Mechanism. Another successful element of a fraud prevention program is having a fraud reporting mechanism that has been written and communicated to all employees. This mechanism could be as straightforward as a sentence saying "If you think fraud has occurred, or may be occurring, report it to your supervisor, anyone in upper management, General Counsel, or Internal Audit."

3. Risk Assessment. The third element of a successful fraud prevention program involves risk assessments. It is imperative that an entity's business units are annually updating and testing their risk assessments as part of the annual budgetary process. If risk assessments are a regular feature of the entity's business unit activity, then management could emphasize the importance of thorough ongoing risk assessments and appropriate testing and documentation of results.

- 4. Tone at the Top. An additional element critical in a successful fraud prevention program is top management's communication of "tone at the top." This message could easily be communicated in a monthly newsletter. A statement as simple as "all department employees should be alert to fraud indicators and should report such matters promptly to the appropriate parties" would be all that is needed to demonstrate just how serious top management takes the issue of fraud in its entity.
- 5. Communication of expectations to non-employees. The last essential element, for purposes of this article, is communication of the entity's expectations to contractors, vendors, and other non-staff individuals. For example, an entity could stress that invoiced amounts should be "true, correct and complete," and that "only eligible costs should be included." This language could be incorporated into the award letter, or included in other written communications from the entity to its contractors.

As noted earlier, the items listed above are not an exhaustive list of elements required for a sound fraud prevention program, but they are considered (if only by me) to be the most essential. 

<u>Brooklyn Sawyers</u>, Assistant United States Attorney, Eastern District of Tennessee, presenting on **federal money laundering** statutes and detailed discussion of money laundering offense elements and financial investigations and tips. She will also cover various **federal fraud statutes** including prosecutions for theft of government funds.

Mark Hall, Supervisor of Training, TN Law Enforcement Training Academy, presenting Statement Analysis. Known as "SCAN", the process by which an investigator examines a statement prepared by an individual to test the veracity of the information provided.
