Mr. Bishop's presentation revealed to us the investigative and interview techniques used to gather this information. All of the nitty gritty details of this story can be read in his book entitled, "A Murder in Music City: Corruption, Scandal, and the Framing of an Innocent Man."

October Luncheon Speaker

Sam Alzoubi, CFE

Director of Audit Services Tennessee Department of Human Services



In addition to serving as the Director of Audit Services at the Tennessee Department of Human Services, Sam served as Interim Chief Officer of the Program Integrity area for almost one year, taking on responsibilities of multiple divisions throughout Tennessee.

Prior to working at DHS, Sam was a member of the Comptroller's Office Legislative Auditors within the State Audit Division for over 16 years.

During his tenure at DHS, Sam has assisted with many improvements, in-

cluding

- Procure and implement electronic auditing software (ACL) to significantly reduce the reliance on paper. ACL was put to use 3 months ahead of schedule.
- Restructured the Audit Services Division into 3 subdivisions for effectiveness and efficiency.
- Coordinate efforts to process potential SNAP fraud in a timely manner.
- Increase the State Law Enforcement Bureau (SLEB) agreements between DHS and Police and Sherriff departments within the State to mitigate the risk of SNAP trafficking.
- Provide, as part of the employee's professional and learning development, Certified Fraud Examiner study materials to 27 of the Audit Services staff. Currently there are 17 CFEs within the DHS Audit Services Division.
- Investigate and follow up on allegations of fraud or misappropriation of State's assets.

Sam is a graduate of **The University of Memphis** with a B.A. in Accounting, and **Yarmouk University**, with a B.A. in Finance. Sam also is a member of the Tennessee Executive Internal Auditor Advisory and Auditing Standards Committees.

Member Spotlight Greg Dozier

The Early Years:

- 1. I'm a native! Born and raised in the Nashville and Middle Tennessee area my entire life.
- 2. Educated in Metro Nashville/Davidson County elementary schools; educated via the hard work of my parents, primarily my mother, at David Lipscomb for both junior high school and senior high school.
- 3. As far as interests and hobbies and as a kid and a teenager, I took up tennis at a young age and played regularly for 30 years. Yes, at one time, I had a decent club-level game. Ah, those were the days! I also was an avid bowler and bowled regularly for 35 years. I cultivated interests in reading and music. My book, CD, and DVD collections are quite impressive, if you share my tastes. If you don't then you'd look at it all and think to yourselves, "What a waste of time, effort, and money."

The "Getting Serious Years":

- 1. I've graduated twice from Middle Tennessee State University. Both were undergraduate degrees and about a decade apart. Suffice to say that my academic background is varied and several consider me a highly educated idiot. I've helped in the 'idiot' department when I finally got serious and found a good job worthy of my limited talents and skills.

This unit's duties include audit review, adjustment, preliminary responses for lawsuits, and to defend the audits for the audit division and the Commissioner at the impartial hearings that tax-payer's may request to settle audit issues, procedures, methodologies, etc. That was a truly interesting period of time.
- 4. Currently, I've left the field and I'm working in another office audit unit for tobacco taxes. I've got my toes wet and I'm finding what interesting challenges that the taxpaying public and the Department face in sorting out the legal requirements for tobacco reporting and taxation.
- 5. Now, of interest is this question what have I encountered for potential fraud during my tenure? Well, I've run into two situations while auditing. Due to disclosure laws, it's very limited as to what I can discuss. However, one dealt with collecting sales tax and then finding ways to purposefully and improperly reduce revenues or increase deductions, which were all invalid and developed by the business' president. Another dealt with tax avoidance on large capital goods used strictly for personal use and no business use whatsoever.
- 6. The Department has been moving in the direction of increased professional development. I have been fortunate to have several fellow auditors who have all now completed the CFE exam and have their certifications. This seems to be an area of interest in growth and challenge. The biggest challenges for me personally are two: learning to think like a criminal, and to consistently devote enough time to study thoroughly. The former gives me a small grin; the second gives me a moment to scratch my head...



CFE Prep Course Giveaway

The Middle Tennessee Chapter, ACFE, has a drawing each year to give away a CFE Exam Prep Course, valued at \$745 (member price) to a chapter member who is not yet a CFE. To be eligible:

Contestant must be a member of the Middle Tennessee Chapter of the ACFE, in good standing for at least six (6) months (prior to the date of the drawing).

The Contestant must have not yet earned their CFE certification.

The Contestant must be eligible and willing to meet all requirements to become a Certified Fraud Examiner and sit for the CFE exam by December 31st of the year in which the contestant is determined to be the winner of the contest and receives the prep course.

Should it be determined the winning Contestant has not met the requirements set forth above, the winning contestant must reimburse the Chapter for the cost of the prep course by January 31st in the year following the drawing (i.e. Contestant wins the prep course in June 2018; reimbursement would be due January 2019).

Important Meeting Information

Luncheon Reservation/Cancellation Policy—Please Take Note!

Please be sure you make reservations for the luncheons prior to attending. We need the reservations to plan appropriately for our attendees and to eliminate confusion at the luncheons. You will receive a confirmation email after you submit your reservation.

Luncheons are \$10.00 for members who make their reservations by the reservation deadline, usually the COB one week prior to the luncheon. For members who make a



reservation but do not attend or call to cancel, the cost is \$20.00. Individuals who attend without making a reservation will also be charged \$20.00.

To cancel your reservation and avoid being invoiced for the event, you must notify the reservationist at nicolette.hudson@cot.tn.gov before the reservation deadline (usually one week prior to the date of the event). If you cancel after the deadline or fail to appear at the event, you will be invoiced for the full per-attendee cost, including other fees that apply as deemed appropriate by the Board. Any pre-paid fees that you have will be applied to the invoiced amount.

Any invoices that are unpaid after 60 days will result in the suspension of membership in the Middle Tennessee Chapter under the current Chapter Bylaws Section 3.09, Non-payment of Dues. As a result of suspension, any reservations you make for future events will not be **AC-CEPTED** and you will not be allowed to attend Chapter luncheons or take advantage of member benefits until your outstanding invoices are paid.

We typically have a waiting list for our events, so if you must cancel your reservation, **PLEASE** notify the reservationist at nicolette.hudson@cot.tn.gov as soon as possible, or you may have someone attend in your place to avoid being invoiced for the luncheon. If you have someone take your place, you must notify the reservationist or have the substitution notify the reception/sign-in table at the luncheon when signing-in.

Other exceptions may apply in extreme situations (i.e. death of a family member) and will be reviewed on a case by case basis at the discretion of the Chapter Board at the member's request.

Members, if you are inviting nonmembers to attend who are not first-time attendees, please be sure that they are fully aware of their costs and our cancellation and invoicing policy. First-time guests eat free. After a guest's first visit, he or she will be charged \$20.00 according to the non-member fee schedule. No Free Guests are allowed at joint luncheons, due to elevated costs, or Member Benefits Events, such as the December Luncheon or January Member Benefit Training Day.
